## How does this course relate to the scope of practice for LCSWs, LPCCs or MFTs:

Though every clinician has training is Human Sexuality and Sex Therapy, there is a need for continuing education training in this important area. - 5. Impact of Sexual Offending on Couples
- 6. Trauma and Therapist Self-Care
